Statement of intent

At Parkgate Primary

Our key objectives are to raise the attainment for those in receipt of pupil premium funding and continue to diminish the difference between themselves and their peers. - Employ an ethos where we recognise the 'whole' child and their lived experience, recognising the importance of social and emotional support

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the **2021 to 2022** academic year.

Challenge 1- Gaps in reading, writing and maths

Covid cases still effected our figures. Some specific cases are medical related and social.

Challenge 3- Barriers to learning maybe related to SEND

Some of our PP children also have SEND barriers as well. These are being addressed using QFT (Quality First Teaching), in class support, specific literacy or maths intervention or SALT programmes. In addition, staff continue to have 'up-to date' diabetes training throughout the academic year.

Challenge 4- Wider school opportunities

Throughout the year...

Two sports coaches are continuing with curriculum lessons and provide weekly after school clubs for both KS1 and KS2, throughout the year. This includes football, rugby and athletics etc.

Gymnastics- a local coach provides weekly group gymnastics lessons in school.

Music- Ukulele group and individual tuition and singing group.

Science- 'Mad Science' 10 week programme. 'Bug fest' - travelling insect show.

Cross country running- Provided by a parent.

Residential including 'Tattenhall', 'Hothershall Lodge' and 'Plas Caerdeon'

Individual class trips to 'Boat museum' Ellesmere port, 'Riveracre Valley', Blue Planet Aquarium, Ness gardens, Western Approaches, World Museum, Museum of Liverpool Seacombe Lighthouse and Chester Zoo.

Challenge 5- Parental Engagement

We have seen much improved parental engagement this year following the lifting of restrictions imposed during the pandemic. The impact of this has been significant as the PTA have been able to fund-raise more events for both the children and their parents. Events have included a Christmas Fair, Summer fair, Chocolate Bingo, children's discos, and a ball.

Unfortunately, class workshops have still not resumed, and most parent meetings are a hybrid of zoom and face to face.

Newsletters continue to be sent home every half term to promote home/school links. Twitter, Facebook Google classroom and Tapestry continue to engage the parents in school life.
